Head west on I-95 S Toll Road 0.5 mi Keep left to stay on I-95 S Toll Road 2.4 mi Take exit 14-14C for I-78

W toward US-1/US-9 Toll Road 1.8 mi Continue onto I-78 W Toll Road 0.1 mi

Keep right at the fork to stay on I-78 W Toll Road 0.4 mi Keep right to stay on I-78 W0.7 mi

Take exit 57 toward US-1 S/US-9 S/Elizabeth 1.3 mi Get on NJ-81 S in Elizabeth 1 min (1.2 mi) Use the right lane to turn slightly right (signs for US-1 S/US-9 S) 0.2 mi Keep right 0.4 mi Keep left 0.1 mi Continue straight
